### Entry Rules: Please Read Carefully

This sale is for Members in good standing of Artists by The Lake. To join you must have a current RCSC card and pay dues of \$5 to join until end of 2020 .

All artwork must be for sale.

Each artist may enter up to **4 pieces**. A non-refundable entry fee is \$5 per artwork paid at time of entry with check payable to: Artists by the Lake.

A blue card must be filled out for each piece of artwork. Please print. The smaller card can be attached to the art. Entry cards are available in the Artists by The Lake Art room. Open Mon-Friday 9-12 and will be available at check-in. Each artist exhibiting work will sign a Holds Harmless Agreement in the event of any damage or loss of the artist's artwork. **On the back** of your art please label with Your name, Title, size, medium, and price so we get the correct labels with the piece when hanging. . Each artist exhibiting work will sign a Holds Harmless Agreement in the event of any damage or loss of the artist's artwork. A copy of such will be given to WHAM on the day of set up of the exhibit. If there is an act of God and damage occurs, the insurance shall cover the price set on each piece of art being displayed for this exhibit.

A 20% commission is collected on all sales by WHAM. They are handling all sales and will have docents to monitor art throughout the month. The 20% is a donation to WHAM which you are responsible for paying WHAM after the sale.

WHAM will provide Docents that will be present to sell and curate the exhibit during WHAM's normal business hours when the gallery is open to the public, Tuesday through Saturday from 10am to 4pm. Due to COVID-19, masks, social distancing and numbers of attendees may be restricted.

You may submit a single page biography along with your entry card.

### To be accepted your artwork must be:

- On display for the entire show. Pick up art on Oct 31<sup>st</sup> from 9-12 AM. If you can not pick up let us know and make other arrangements please.
- Only original art, not a copy of other artist's work. Work based on photo must have photographer's permission.
- Artwork should be framed unless on back-stapled canvas which should be painted around edge.
- Do not submit art completed in a class as a group exercise. Do not submit work completed by someone else or the teacher.
- No reproductions.
- Recent work please! Something created in the last 2 years please.
- Ready for Hanging . This means it MUST HAVE braided picture wire that is well anchored to the frame. No staples, tape. No Sawtooth Hangers!
- Use Acrylic/plexiglass on work larger than 22"x26"

**Accepted Mediums**

Oil, Acrylic, pastel, colored pencil, ink, alcohol ink, graphite, charcoal, fabric and quilting, wax(encaustic), Glue(collage), Digital Art, Original handmade prints by the artist indicating print # and edition size. eg.3/10 .

There are a few pedestals we can use so we are accepting 3-D work which could include clay, 3-D construction, assemblage, sculpture.
